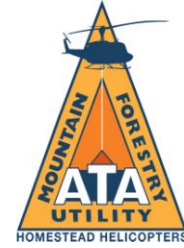

-ROTORCRAFT EXTERNAL LOAD COMBINATION COURSE

10 Hrs. Ground Academics	COSTS: \$15,750.00	\$23,750.00

*Course designed for commercial rated pilots with little to no experience in VTR/External Load operations. Course will train pilots to HHI ATA VTR Standards which with successful completion will meet and exceed USFS/DOI VTR flight evaluation standards.

Min. Requirements: 500 Hrs. PIC Helicopters / 50 Hrs. Turbine Helicopters
Duration: 2 Weeks

-HELICOPTER FIREFIGHTING / FORESTRY TACTICS & MOUNTAIN FLYING

5-7 Hrs. Flight Training	(Jet Ranger 206BIII)	(Long Ranger 206L4)

*Course designed for commercial rated pilots with experience in VTR operations and the mountain flying environment but have little to no experience in Helicopter Fire Fighting. Pilots will learn Fire Tactics / behavior and be evaluated to HHI ATA VTR Standards which with successful completion will meet and exceed USFS/DOI VTR flight evaluation standards while getting a refresher in Helicopter Mountain flying techniques.

Min. Requirements: 1500 Hrs. PIC Helicopters / 200 Hrs. Turbine Helicopters
100 Hrs. Mountain Helicopters / 50 Hrs. VTR Helicopters
Duration: 1 Week

-BASIC HELICOPTER MOUNTAIN FLYING TECHNIQUE

Min. Requirements: Previous experience must be documented. Approval for course is based on previous experience at HHI ATA discretion.
